
The following are the minutes of meeting.


1. Principal welcomed all the new committee members and thanked them for accepting to be a member of the committee.
2. The committee took review of the round of the surprise visits made by the anti ragging squads. The committee expressed satisfaction with the records maintained.



7. Meeting ended with vote of thanks to the Chair.


